1. Question – Are there any recent updates we need to know about?

- a. The petition is with the Chancellor (district lawyer)
- b. The Discernment Steering Committee has written the Bishop and Annual Conference Trustees to clarify the timing related to our discernment and whether our exit fee will stay the same as it would be for a 2024 exit.
- c. The date for vote is no earlier than June 1, per the vote of Church Council.
- d. The Discernment Steering Committee serves at the pleasure of what church Council and under the guidelines established by their vote.
- e. Other churches did not go in the same direction as Bethany. This Church Council felt Bethany needed to go through discernment, but also needed to see what was going to happen at the General Conference before a church vote was taken.
- f. The Bishop and Trustees of the Annual Conference determine the rules for separating from the UMC.

2. Comment

- a. I am disappointed in the UMC.

- c. I see no reasons to make the Bible fit societal issues.
